Horizon Europe (HEU)

[HEU](#) is a 95.5-billion-euro funding programme for R&I, that covers all major scientific and technological disciplines, and encourages collaborative projects (consortia) for a joint goal.

- Consortium –
 - ✓ At least 3 partners from 3 different countries participating in the programme
 - ✓ At least 1 partner must be from a member state (EU country)
 - ✓ A partner can be any legal entity – university, company, agency, end-user, government entity etc...
- Funding Tools –

Action	Funding*	Main Characteristics
RIA – Research & Innovation Action	100% + 25%	Basic and applied research , technology development and integration, testing and validation - small-scale prototype in a laboratory or simulated environment. Usually low TRL (1-4)
IA – Innovation Action	70% + 25%	Prototyping , testing, demonstrating, piloting, large-scale product validation and market replication . Usually high TRL (5-8)
CSA – Coordination & Support Action	100% + 25%	Networking , coordination or support services , policy dialogues and mutual learning exercises and studies

* Non-profit: always 100% + 25% overhead

Cluster 3 work programme goals: support the implementation of EU policy priorities on **security, including cybersecurity, and disaster risk reduction and resilience**. In addition, building on lessons learnt from the COVID-19 pandemic to **strengthen prevention, mitigation, preparedness and capacity building for crises** (including health crises) and to **improve cross-sectoral** aspects of such crises.
